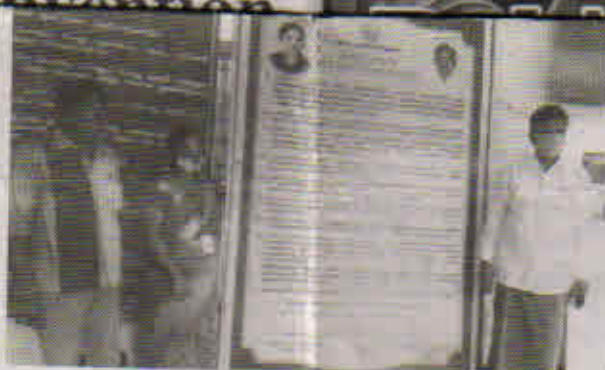

Sir,
 The draconian lockdown due to the spread of Covid-19 has damaged many rail projects like the 41 km. Karaikkal-Tiruvavur line without adequate trains. The section was electrified and obtained the mandatory nod from the Railway Safety Commissioner three months ago. Similarly, the 148 km. Newly converted Tiruvavur-Pattukottai-Aranthangi-Karaikkudi line was electrified by the 'CORE' an engineering wing of Railways a year ago and thrown open to traffic and no train service was resumed.
 As a super senior citizen aged 89, I request the Railways to introduce a train service of 189 kms. From Karaikkal (Puducherry Union Territory) to Karaikkudi in Tamil Nadu on 15.08.2020 Independence Day since this is an inter-state project which will boost the infrastructure of the region.
 Tamil Nadu being the sixth most populous states in the country and one of the highly passenger revenue generating states in the country lags behind many states due to the step-motherly treatment by the Congress for decades. The lockdown has also played havoc and caused and wrecked the economy. Hope the Railway Minister Piyush Goyal will give his nod of approval in this regard.
